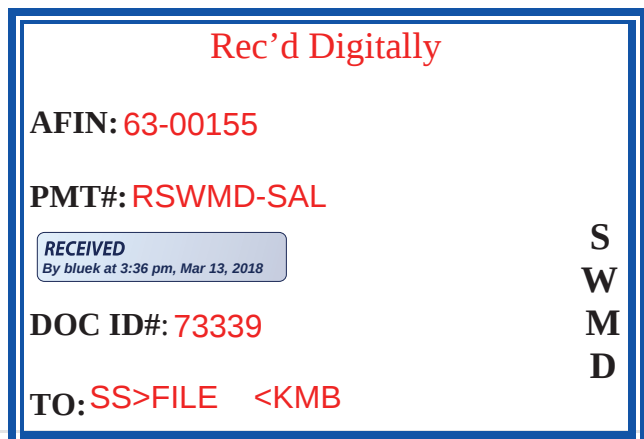

Yes, we advertise the Board meetings on our website, and any resolution that is brought to the Board is advertised in the local newspaper the Saline Courier and filed with the Secretary of State office.

2.9 Public Education and Support

2.9.1 Provide information on the programs and resources utilized by the district to provide education to the general public.

The District provides public awareness through several mediums. We host our own website recyclesaline.org where residents of Saline County can go to find out any information regarding recycling and electronic waste drop off events. We manage our own Facebook page where we post important updates and create an event inviting people to join. We maintain an email database where we collect emails from people that

purchase Landfill Coupons in our office and we email them any updates pertaining to Recycle Saline. We utilize local advertising through the local paper, radio stations, and by either issuing a press release or purchasing ad space.

The District oversees the YEA! Team Program (Youth Environmental Ambassadors) where we work with all the Saline County schools promoting recycling. The YEA! Teams also volunteer at Recycle Saline's recycling drop off events where they are engaged with proper recycling and placement of items being dropped off.

2.9.2 How is the public informed of the goals and objectives, as well as achievement of the goals?

The District will issue a Press Releases to all the local media as well as post updates on our Facebook page and website recyclesaline.org.

2.9.3 How is the public informed of the services, available facilities, and programs of the District?

The District provides public awareness for the services and the programs offered through several mediums. We host our own website recyclesaline.org where residents of Saline County can go to find out any information regarding recycling and electronic waste drop off events. We manage our own Facebook page where we post important updates and create an event inviting people to join. We maintain an email database where we collect emails from people that purchase Landfill Coupons in our office, and we email them updates about services and programs. We utilize local advertising through the local paper, radio stations, and by either issuing a press release or purchasing ad space. We partner with the Benton and Bryant Chamber of Commerce, utilize newsletters in water bills, and word of mouth when residents purchase their landfill coupons at the District office.

2.9.4 How is the public involved in the planning and participation of events and programs supporting the district's goals and objectives?

Any comments that come from the recyclesaline.org website, Facebook or Public Comment from our Board meetings are taken into consideration when planning events and planning to have volunteers for events.

2.10 Programs for Elimination of Illegal Dumping and Open Burning

2.10.1 Explain the RSWMDs programs, enforcement efforts, and public education initiatives to eliminate open burning and burn barrels within the District.

Recycle Saline employs a full time Illegal Dumps Control Officer (IDCO). The IDCO patrols all of Saline County in search of any type of illegal burning within the county, this also includes burn barrels. If any type of illegal burning or burn barrels are reported, the IDCO conducts a one on one interview with the property owner, to educate them on state law concerning burning. The IDCO will leave with the property owner, materials from ADEQ and Recycle Saline on the legalities and health issues surrounding illegal burning. The IDCO will also leave with the property owner; a list of all solid waste haulers that are permitted to operate within Saline County, which can provide proper disposal of their household waste.

Recycle Saline has partnered with the Saline County Emergency Dispatch Office, this partnership allows Saline County residents to contact both 911 and non-emergency to report illegal burning/dumping. The dispatch will then contact the IDCO for intervention.

2.10.2 Provide information on current illegal dump site locations and what programs the District has in place to eliminate these sites.

Recycle Saline employs a full time illegal Dumps Control Officer (IDCO). The IDCO patrols all of Saline County in search of any type of illegal dumping within the county. The IDCO has identified the “problem” areas within the county and the IDCO has developed a routine schedule of patrols for these areas. Recycle Saline, has developed a four-part court ordered citation book, which is used to issue both warnings and ordered court appearances for any offenders of the solid waste act, within Saline County. The IDCO also distributes educational materials to all offenders of the solid waste act, which helps Saline County residents to better understand how to properly dispose of solid waste materials.

The IDCO will also, on annual basis conduct public education events via the public schools, community organizations, and all Saline County fire departments. During these events education materials are distributed that disseminate information on both illegal burning and dumping of solid waste inside Saline County.

Recycle Saline has also established an anonymous tip line, where Saline County residents can call in and leave information concerning illegal burning, illegal dumping, or any other information concerning solid waste and litter issues.

- 3 Waste Categories** - Provide a spreadsheet or table categorizing solid waste as being generated by residential households and commercial entities, as well as waste generated by industries within the District.

- 3.1 Residential and Commercial Waste Estimation** - can be estimated utilizing a per capita generation rate. The most recent information provided by EPA indicates that household and commercial waste (known as municipal solid waste or MSW) is produced at a rate of 4.43 pounds per person per day.

Based upon the most current population data, it is estimated that Saline County residents will produce 474,532.74 pounds of solid waste per day or 237.26 tons per day. MSW = 67.62 tons per day.

- 3.2 Municipal Solid Waste Makeup** - can be computed by utilizing the percent of material commonly found in the waste stream and the populations for each county of the state. This information, found on the website for the U.S. Census Bureau, Population Division, is provided on following pages.

- 3.3 Industrial Waste Generation** - Industrial Waste generation rates can differ significantly from one locale to another.

The Information obtained under this Element will then be used by the RSWMDs and the state to determine the amount of material available in each city and county. Utilizing the population and estimated volume of waste generated by each person on a per day basis (4.43 lbs.), the amount of waste within a RSWMD can be predicted.

A plan area with 200,000 people could be expected to generate 161,695 tons of MSW, not including industrial waste from large manufacturing facilities.

Example: $200,000 \times 4.43 \text{ (lbs.)} \times 365 \text{ (days)} / 2000\text{lbs} = 161,695 \text{ tons of MSW}$

Each material of the waste stream can then be estimated, such as 46,083 tons of Paper and Paperboard.

Example: $161,695 \text{ tons MSW} \times 28.5 \% \text{ percent of waste stream} = 46,083 \text{ tons.}$

Executive Summary

The Saline County Regional Solid Waste Management District consists of a single county located in Central Arkansas. The District Board is comprised of the Mayors or their appointee of the Class A cities: Benton, Bryant, Shannon Hills, Alexander, Haskell, and the Saline County Judge. The largest cities in the District are Bryant with a population of 20,141 and Benton with a population of 34,669.

Republic Services owns the Class 1 and Class IV landfill in Saline County. Curbside solid waste collection is provided by nineteen independent solid waste haulers and is available to all residential households on a voluntary basis. Trash service isn't a mandatory requirement by the cities or county.

Republic Services and Pure Waste are the only waste haulers in Saline County that offer curbside recycling pick-up. We do foresee that other waste haulers in the county will start offering curbside recycling as part of their services as well. County-wide residential recycling is available to Saline County residents at the Republic Services Landfill for no charge. The District provides three recycling events a year for residents in the county to dispose of metal, electronics, tires, and bicycles. Once a year in the fall we host a Household Hazardous Waste drop-off for bulbs, batteries, paint, and chemicals in partnership with Rineco. Rineco is responsible for the proper handling of the materials on site and then transports to their facility in Haskell for proper disposal.

Currently, the District is funded through royalty fees from the Saline County Republic Services Landfill, waste hauler licensing fees, and the Landfill Coupon Program. The District also relies on recycling and e-waste grants from ADEQ to help fund the recycling and electronic waste drop off events as well as helping non-profits with recycling pick-ups and transporting those materials to local MRF's.

The District will continue its role in providing education, administrative, and planning in the implementation of programs such as recycling, recycling education, public awareness, and enforcement in the county.

Our YEA! Team program is a big part of the education process for recycling in Saline County. We see this program evolving by recruiting more students to be apart of the program and extending their spirit of volunteerism in the community by working with key organizations such as Keep Arkansas Beautiful, Keep Bryant Beautiful, and Benton Matters. Smarty the District mascot has a great deal of responsibility in the educational process. He attends many community events as well as making appearances to the schools teaching kids and administrators about recycling. Re-Fashion Bash is going into its fourth year and has proved to be an intricate part of the YEA! Team program. Through this education process students plan and create designs with the 3 R's in mind. This trendy event has shown growth each year with runway participation as well as audience participation. Partnerships have been a huge part in the making of Re-Fashion Bash each year bringing in companies like Verizon Wireless, local non-profits such as Habitat for Humanity, and local small businesses to help increase the awareness of recycling in the community.

The District places a big emphasis on the Illegal Dumps Control program. We consider the regulatory and enforcement responsibilities of the Solid Waste District as opportunities to enhance the educational settings for the residents in Saline County. We use these opportunities to educate residents about the proper methods for disposal. It is our goal to eliminate dumpsites with the increase in education and offering the Landfill Coupon program, and clean-up 100,000 pounds or 52 tons of illegally disposed materials per year, with proper placement of illegal waste in an environmentally safe way.

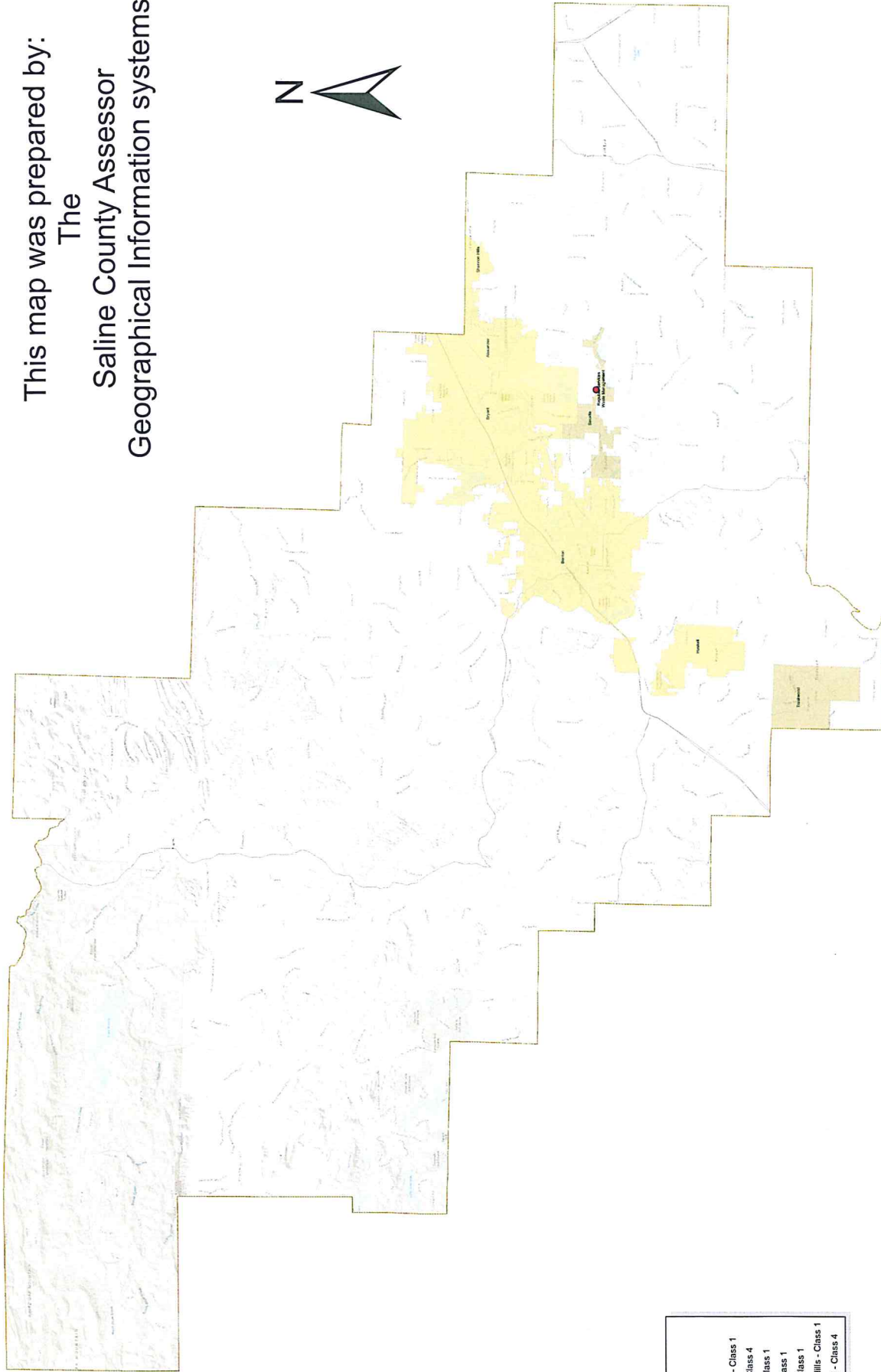

By-Laws

For

Saline County Regional Solid Waste Management Board

Article I

Organization

- 1.01 **Jurisdictional Boundaries** – The Saline County Regional Solid Waste Management District, hereinafter referred to as “The District”, shall encompass the entire county of Saline.

Article II

Regional Solid Waste Management District Board

- 2.01 **Creation** – The District shall be governed by a regional solid waste management board, hereinafter called “The Board”.
- 2.02 **Members** – The Board shall be composed of the following, to be amended according pursuant to ACT 752 of 1991:
- Saline County Judge (or his/her designee)
 - Mayor of Alexander (or his/her designee)
 - Mayor of Benton (or his/her designee)
 - Mayor of Bryant (or his/her designee)
 - Mayor of Haskell (or his/her designee)
 - Mayor of Shannon Hills (or his/her designee)
- 2.03 **Chairman** – The Board shall select a chairman annually.
- 2.04 **Secretary** – The County Judge shall serve as the secretary.
- 2.05 **Voting** – A majority of the membership of The Board shall constitute a quorum. A majority vote of The Board members shall be required for any action of The Board.

Article III

Purpose

- 3.01 **Purpose** – The purpose of The District is the protection of the public health and the State's environmental quality through the development and maintenance of a solid waste plan for the people of Saline County. Further, The District shall serve to address local exigencies and other requirements as are more clearly defined in ACT 752 of 1991.

Article IV

Powers and Duties

- 4.01 **Powers and Duties** – The Board shall have those duties and powers as set forth in ACT 752 of 1991 (Codified as A.C.A. 8-6-704) and set out herein below:
1. To collect data, study, and initially evaluate the solid waste management needs of all localities within their districts, as provided in § 8-6-716, and to publish their findings as a regional needs assessment;
 2. To evaluate on a continuous basis the solid waste needs of their districts and thereby update the regional needs assessments at least biennially;
 3. To formulate recommendations to all local governments within their districts on solid waste management issues and to formulate plans for providing adequate solid waste management;
 4. To issue or deny certificates of need to any applicant for a solid waste disposal facility permit within their districts with the exception of permits for landfills when a private industry bears the expense of operating and maintaining the landfill solely for the disposal of waste generated by the industry or wastes of a similar kind or character;
 5. To petition the Director of the Arkansas Department of Environmental Quality to issue, continue in effect, revoke, modify, or deny any permit for any element of a solid waste management system located within a district based on compliance or noncompliance with the solid waste management plan of the district;
 6. To adopt rules under the Arkansas Administrative Procedure Act, § 25-15-201 et seq., as are reasonably necessary to assure public notice and participation in any findings or rulings of the boards and to administer the duties of the boards;
 7. To establish programs to encourage recycling;
 8. To adopt official seals and alter them at pleasure;
 9. To maintain offices at such places as they may determine;
 10. To sue and be sued in their own names and to plead and be impleaded;
 11. To make and execute contracts and other instruments necessary or convenient in the exercise of the powers and functions of a district, including, but not limited to, entering into contracts and agreements with private entities for provision of services;

12. To carry out all other powers and duties conferred by this subchapter and § 8-6-801 et seq.;

13.

- a. To enter into agreements with another solid waste management district to allow a district or any person within that district to transfer solid waste into another district.
- b. However, notice of all such authorizations shall be submitted to the Arkansas Department of Environmental Quality within thirty (30) days and shall be incorporated into the regional needs assessment in its next regular update; and

14.

- a. To authorize a disposal facility within a district to accept the receipt of solid waste from an adjoining district upon request by the generator of that solid waste, provided that the request specifies the disposal facility and the nature and estimated annual volume of solid waste to be received.
- b. However, notice of all such authorizations shall be submitted to the department within thirty (30) days and shall be incorporated into the regional needs assessment in its next regular update.

(b) (1) The regional solid waste management boards may:

- a. Apply for such permits, licenses, certificates, or approvals as may be necessary to construct, maintain, and operate any portion of a solid waste management system and to obtain, hold, and use licenses, permits, certificates, or approvals in the same manner as any other person or operating unit of any other person;
- b. Employ such engineers, architects, attorneys, real estate counselors, appraisers, financial advisors, and other consultants and employees as may be required in the judgment of the district and fix and pay their compensation from funds available to the district therefore;
- c. Purchase all kinds of insurance, including, but not limited to, insurance against tort liability, business interruption, and risks of damage to property; and
- d. Employ an environmental officer who may:
 - (i) Inspect all landfills;
 - (ii) Inspect other solid waste facilities;
 - (iii) Inspect waste haulers and other vehicles;
 - (iv) Ensure compliance with all district regulations;
 - (v) Collect evidence of noncompliance and present the evidence to the prosecuting attorney; or
 - (vi) Issue citations for the violation of any district regulation.

(2)

- a. If a regional solid waste management board employs an environmental officer under this subsection, then the environmental officer may complete the training course for law enforcement officers at the Arkansas Law Enforcement Training Academy.
- b. After satisfactory completion of the training course, the environmental officer shall be a law enforcement officer.
- c. After satisfactory completion of the training course, the environmental officer may:
 - (i) Carry firearms;
 - (ii) Execute and serve a warrant or other processes issued under the authority of the district and related to violations of district regulations; and
 - (iii) Make arrests and issue citations for violations of district regulations regarding environmental protection.

(c) The regional solid waste management boards shall adopt and follow county purchasing procedures, as provided in § 14-22-101 et seq., as the approved purchasing procedures for the districts.

(d) (1) Each regional solid waste management board shall procure an annual financial audit of the district. Such audits shall be conducted following each board's fiscal year end. Regional solid waste management funds which are subject to audit in conjunction with a single audit performed consistent with Governmental Auditing and Reporting Standards are not required to have a separate audit.

(2)

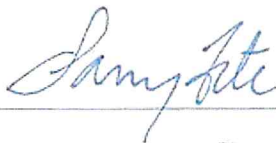
- a. Each district shall choose and employ accountants in good standing with the Arkansas State Board of Public Accountancy to conduct these audits in accordance with Governmental Auditing and Reporting Standards issued by the Comptroller of the Currency of the United States.
- b. The regional solid waste management district shall pay for such audits from their administrative moneys.

- (3) Each audit report and accompanying comments and recommendations shall be reviewed by the appropriate regional solid waste management board.
- (4) Copies of each audit report of a regional solid waste management district shall be filed with the department and with the Division of Legislative Audit. In addition, one (1) copy of the audit report shall be kept for public inspection with the books and records of the district.
- (5) Failure to provide a full and complete audit report, as required by this subchapter, shall prohibit future distribution of revenue from funding programs that are administered by the department unless otherwise authorized by the director.

Article V

General Provisions

- 5.01 **Amendment of By-Laws** – These By-Laws may be amended, or repealed at any meeting of The Board at which quorum is present, by the affirmative vote of (4) four Board members, provided 30 day notice of the proposed alteration, amendment, or repeal is contained in the notice of the meeting.
- 5.02 **Construction** – If any portion of these By-Laws shall be invalid or inoperative, then so as is reasonable and possible:
 - a. The remainder of these By-Laws shall be considered valid and operative:
and
 - b. Effect shall be given to the intent manifested by the portion held invalid or inoperative.

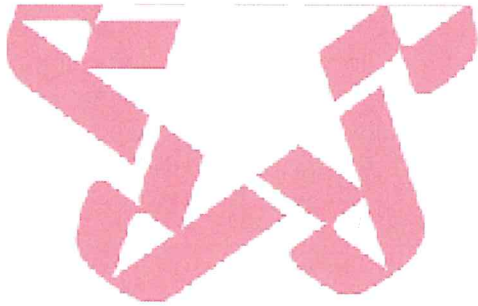
