11010005-001-Lower Buffalo River, site name BUFR09, was listed as impaired for temperature in 2010, but was delisted in 2012.

11010005-027-Big Creek, site name BUFT18, was on the 2014 list for dissolved oxygen in 2014, but is on the removed listings (draft) for 2016.

The 2010, 2012, and 2014 303(d) lists have yet to be approved by EPA. Each one will have be reviewed and approved by EPA in chronological order.
